02. I agree to present the Rain International Marketing and Compensation Plan and Rain International products and services as set forth in official Rain International literature.
03. I agree that as a Rain International Distributor I am an independent contractor, and not an employee, partner, legal representative, or franchisee of Rain International.
04. I have carefully read and agree to comply with the Rain International Policies and Procedures and the Rain International Compensation Plan, both of which are incorporated into and made a part of these Terms and Conditions.
05. The term of this Agreement is one year (subject to prior cancellation as provided in the Policies and Procedures).
06. I may not assign any rights or delegate my duties under the Agreement without the prior written consent of Rain International.
07. I understand that if I fail to comply with the terms of the Agreement, Rain International may, at its discretion, impose upon me disciplinary action as set forth in the Policies and Procedures.
08. Rain International, its parent or affiliated companies, directors, officers, shareholders, employees, assigns, and agents (collectively referred to as "affiliates"), shall not be liable for, and I release and hold harmless Rain International and its affiliates from, all claims for consequential and exemplary damages for any claim or cause of action relating to the Agreement.
09. The Agreement, in its current form and as amended by Rain International at its discretion, constitutes the entire contract between Rain International and myself.
10. Any waiver by Rain International of any breach of the Agreement must be in writing and signed by an authorized officer of Rain International.
11. If any provision of the Agreement is held to be invalid or unenforceable, such provision shall be reformed only to the extent necessary to make it enforceable, and the balance of the Agreement will remain in full force and effect.
12. This Agreement will be governed by and construed in accordance with the laws of the State of Utah without regard to principles of conflicts of laws.
13.
